ACTION ITEM: Arkansas State University, Arkansas State University-Beebe, Arkansas State University-Mountain Home, Arkansas State University-Newport, Arkansas State University Mid-South, Arkansas State University Three Rivers, and Henderson State University request approval to set tuition, fees, and room and board rates.

ISSUE: The Board of Trustees must approve tuition, fees, and room and board rates.

BACKGROUND:

In order to meet the additional costs needed to fulfill its mission, the Arkansas State University System requests approval for its campuses to adjust tuition, fees, and room and board rates.

SUMMARY OF TUITION AND MANDATORY FEE IMPACT

The following charts were prepared in accordance with the Arkansas Division of Higher Education (ADHE) and the Southern Regional Education Board (SREB) reporting standards by calculating the impact of tuition and mandatory fees for a full-time, in-state, undergraduate student. "Full-time" is defined as an undergraduate student, who carries 15 credit hours per semester or 30 credit hours annually.

ACTION ITEM: The Arkansas State University System (System) requests approval of the FY2025 operating budgets and the authority to execute these budgets during the fiscal year.

ISSUE: Each fiscal year, the Board of Trustees must approve the operating budgets of the System.

BACKGROUND:

The operating budget establishes expenditure levels for certain categories of expense, including salaries, supplies and services, and capital-related expenditures. Moreover, the budget establishes sound fiscal policy, by which the University manages its annual fiscal affairs.

ARKANSAS STATE UNIVERSITY:

The Arkansas State University (A-State) FY2025 operating budget was developed through the efforts of the University's Executive Budget Council and shared with the Chancellor's Cabinet, which has representation from all its constituent groups across campus.

The budget will include \$59.7 million in state appropriation funds (Categories "A" and "B"), \$9.3 million in Educational Excellence Trust Fund monies, tuition revenues based on flat enrollment and a 4.3% tuition and mandatory fee increase. In addition, A-State will be offering an Optional Voluntary Retirement Incentive Plan (OVRIP), of which 17 faculty and 21 staff have already agreed to take part in.

Funds were allocated to the following categories:

- Faculty promotions;
- A 2% merit raise for faculty and non-classified employees;
- A 10% increase in graduate assistant stipends; and
- Software for Accreditation and Assessment purposes.

The A-State budget for FY2025 is \$183,391,893 for Educational and General Operations, and \$37,762,181 for Auxiliary Operations.

ARKANSAS STATE UNIVERSITY-BEEBE:

The FY2025 operating budget for Arkansas State University-Beebe (ASUB) was developed using a "One College" collaborative budget process that included budget managers across all campuses, ensuring that all departments and locations were represented. The Shared Governance committee, which includes representatives from the faculty and staff senates and the Student Government Association, reviewed and endorsed departmental and program budget requests. ASUB continued a modified, zero-based budgeting process, ensuring continued efforts in efficiency, while addressing areas of need in delivering high-quality educational services to students and other campus constituents.

The FY2025 operating budget includes the following major revenue sources: \$11,645,791 in state appropriation funds; \$2,312,204 in Educational Excellence Trust Funds; and \$801,945 in Workforce 2000 funds. Due to uncertainty in enrollment forecasts for FY2025, a tuition and fee revenue of \$9,978,564 is anticipated. This is based on a 3.6% increase in tuition rates and assuming a flat enrollment, compared to the FY2024 estimated actual enrollment.

ASUB was able to provide a \$1,500 + 2% COLA increase to all faculty and staff for FY2025, through natural attrition, rigorous review of open positions, a 3.6% increase in tuition rates, and reallocation of departmental funds, based on a thorough review of departmental expenses and institutional priorities.

The ASUB budget for FY2025 is \$27,903,706 for Educational and General Operations, and \$1,879,278 for Auxiliary Operations. The proposed operational budget for FY2025 represents an overall increase in budgeted revenue and expenses of approximately 3.45%, as compared to the FY2024 budget.

ARKANSAS STATE UNIVERSITY-MOUNTAIN HOME:

Arkansas State University-Mountain Home (ASUMH) developed the FY2024-2025 Operating Budget through an integrated planning, assessment, and budgeting process, with the institution's long-range goals serving as the overarching guide for decision-making and resource allocation.

The FY2025 budget for ASUMH will include \$3,695,854 in state appropriation funds and Workforce 2000 Funds of \$823,929. Tuition revenues of \$4.8 million are based on a \$4.00 per-credit-hour tuition increase, a \$2.00 per-credit-hour Access and Security fee increase, and a decrease in the per course fee for the Computer Information System classes.

Resources were changed or allocated in the following categories:

- A \$500 + 1% raise for faculty and staff;
- The minimum rate of pay for all full-time positions was increased to \$13.50 per hour;
- Implementation of an organizational structure review added eight new positions and eliminated seven; and
- The Marine Manufacturing faculty position was shifted from grants funding to E&G.

The ASUMH budget for FY2025 is \$11,672,033 for Educational and General Operations, and \$330,000 for Auxiliary Operations.

ARKANSAS STATE UNIVERSITY MID-SOUTH:

In close collaboration with departmental budget managers, the Arkansas State University Mid-South (ASU Mid-South) Chancellor's Executive Council developed the Educational and General Operating Budget for FY2025.

The FY2025 budget for ASU Mid-South will include \$7.7 million in state appropriation funds. Category "A" of RSA Funds will total \$5.5 million, and Workforce 2000 Funds are budgeted at \$2.2 million. Tuition revenues of \$2.59 million are based on a 1% enrollment decline and a requested 5.13% tuition increase.

ASU Mid-South's key initiatives for FY2025 are as follows:

- Providing a minimum of a 1% COLA raise for all eligible employees;
- Supporting the faculty rank-and-promotion program;
- Raising minimum salary levels for all full-time employees to \$14.50/hour;
- Launching softball and e-Sports programs;
- Supporting professional development and training for faculty and staff; and
- Marketing a "last-dollar" scholarship pilot program for eligible Crittenden County residents.

The Arkansas State University Mid-South budget for FY2025 is \$13,193,300 for Educational and General Operations, and \$692,000 for Auxiliary Operations. The proposed operational budget for FY2025 represents an overall increase in budgeted expenses of \$400,000, or 3%, compared to our FY2024 budget.

ARKANSAS STATE UNIVERSITY-NEWPORT:

Arkansas State University-Newport (ASUN) conducted a collaborative budgeting process that allowed for prioritization of requests under a strategic budget model for FY2025. As the College looks to expand its degree offerings to stimulate regional economic growth, ASUN is highly focused on controlling expenses to ensure that the College meets the needs of its students. Inflation continues to have a significant impact on prices, and it increases the cost of supplies and services required for operations. To account for the operational cost increases, yet still maintain a high level of affordability, ASUN held its overall request for tuition and mandatory fee increases to 6.2%. This allows the College to provide cost-of-living increases and a productivity bonus structure to employees, maintain the highest quality levels in the classroom, and still provide an affordable cost of attendance.

Key initiatives are as follows:

- Cost-of-living increases of 1% for faculty and staff;
- Addition of new faculty positions to support new degree offerings in high-demand programs;
- Continuation of a performance bonus program for all full-time employees of up to 2%, based on Key Performance Indicators;
- Evaluation of productivity for academic programs and staff reorganization has resulted in the elimination of two positions (staff and faculty), providing an annual cost savings of \$152,000;
- Allocation for deferred maintenance in the amount of \$150,000;
- Increase in the utilities budget of \$40,000, to account for rate increases; and
- Increase in the budget for property insurance in the amount of \$60,000.

ASUN will continue to place an emphasis on the ambitious goals set forth in its 2023-2027 Strategic Plan, in order to effect student retention and completion, as well as to stimulate regional economic development.

The ASUN FY2025 budget is \$17,917,343 for Educational and General Operations, and \$1,219,000 for Auxiliary Operations.

ARKANSAS STATE UNIVERSITY THREE RIVERS:

The FY2025 operating budgets for Arkansas State University Three Rivers (ASUTR) were submitted by department managers. Cabinet-level officials met several times to discuss budgeted initiatives. Draft versions were presented to the campus Effectiveness Committee as the FY2025 budget was formulated.

Tuition and mandatory fees increased \$9 per credit hour, or 6.1%. A \$2 increase in Academic Excellence fees partially funds the faculty salary base increases for FY2025.

Other highlights of the FY2025 budget include the following:

- Baseball and softball sports programs will continue in FY2025 (no other sports have been added);
- Budgeted salaries include a salary base increase for faculty;
- One new academic program will be added (the Paramedic/EMT program will begin in Spring 2025); and
- The Cosmetology program will be eliminated after the Fall 2024 semester.

The Arkansas State University Three Rivers budget for FY2025 is \$9,315,062 for Educational and General Operations, and \$760,820 for Auxiliary Operations.

HENDERSON STATE UNIVERSITY:

The FY2025 operating budget for Henderson State University (HSU) was developed using a collaborative budget process that included budget managers from across all colleges, ensuring that all departments and programs were represented. The proposed FY2025 budget was presented to the entire campus community. Faculty and staff representatives were allowed to review the budget and were given an opportunity to provide feedback on departmental and program budget requests. HSU continues a modified, zero-based budgeting process, ensuring continued efforts in efficiency, while addressing areas of need in delivering high-quality educational services to students and other campus constituents.

The FY2025 operating budget includes the major revenue source of \$22,640,844 in state appropriation funds. Due to uncertainty in enrollment forecasts for FY2025, a tuition and fee revenue of \$17,001,816 is anticipated, based on a 10% decrease in enrollment, compared to the FY2024 estimated actual enrollment.

HSU was unable to provide a COLA increase to faculty and staff for FY2025. After a rigorous review of natural attrition, current open positions, reallocation of departmental funds based on a thorough review of departmental expenses and institutional priorities, and an 8% increase in tuition rates, it was determined that an across-the-board raise for HSU personnel wasn't economically feasible for FY2025.

The HSU proposed budget for FY2025 is \$35,438,815 for Educational and General Operations, and \$16,775,870 for Auxiliary Operations. The proposed operational budget for FY2025 represents an overall increase in budgeted revenue and expenses of approximately 1%, as compared to the FY2024 budget.

ARKANSAS STATE UNIVERSITY SYSTEM:

The Arkansas State University System Office is funded as a non-formula entity with an FY2025 operating budget of \$4,861,913, of which \$2,871,417 is categorized as state appropriation, and \$1,990,496 coming from other sources, including institution and Foundation support.

After determining availability of revenues, the President may approve requests for one-time bonus plans and additional salary plans for FY2025.

RECOMMENDATION/RESOLUTION:

Be it resolved that the Arkansas State University System operating budgets and salary adjustment plans are approved, and authority is granted to execute the budgets in the amount of \$303,694,065 for Educational and General Operations, and \$59,419,149 for Auxiliary Operations.

ACTION ITEM:

The Arkansas State University System (System) requests approval of its FY2025 capital project and expense budget and the authority to execute the budget during the fiscal year.

ISSUE:

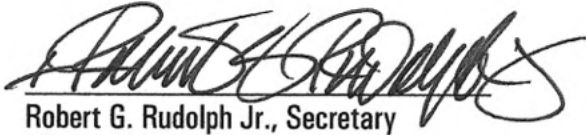
Each fiscal year, the Board of Trustees must approve the capital project and expense budget of the System.

BACKGROUND:

- As the System has a significant investment in its plant and capital, it is requesting to establish an annual capital expenditure budget to illustrate commitment to maintenance of its capital investment. Currently, the System includes a total of 2,341 land acres and 384 buildings, comprising 7,126,479 square feet.
- The state of Arkansas provides no dedicated revenue stream for capital projects or deferred maintenance needs.
- The System currently contains \$368.8 million in total deferred maintenance needs, according to the Facilities Audit Program conducted by the Arkansas Division of Higher Education.
- The proposed ASU System FY2025 capital project and expense budget is attached to this resolution.

RECOMMENDATION/RESOLUTION:

Be it resolved that the Arkansas State University System's FY2025 capital project and expense budget is approved and authority is granted to execute the budget.

ASU System Policy

Effective Date: June 6, 2024

Subject: Board of Visitors

Purpose

A Board of Visitors may be established for member institutions within the Arkansas State University System. This policy shall be used to appoint individuals to a Board of Visitors, unless a different process is provided by law.

Arkansas State University System Board of Visitors Policy

1. The general purpose of a Board of Visitors shall be to serve as an advisory body. Specifically, the Board shall be charged with the following duties:
 - A. To perform a liaison and advisory function between each member institution and residents of the member institution's service area;
 - B. To aid in securing financial support for the member institution;
 - C. To give advice to the Chancellor concerning the educational and service needs of the service area;
 - D. To advise the Chancellor regarding institution-specific issues;
 - E. To provide counsel and guidance to the member institution's Chancellor; and
 - F. To designate additional duties authorized by the President of the Arkansas State University System.
2. The Board of Visitors shall have no formal governing authority, or authority to bind a system campus to any agreement. However, the Chancellor shall seek input from the Board of Visitors on all action items, prior to those items being presented to the ASU System President and Board of Trustees for consideration at a Board meeting.
3. Each Board of Visitors shall consist of five, seven, or nine members. The Chancellor of each member institution shall have discretion to determine the appropriate number of Visitors for their respective institution.
4. The term of office for Board of Visitors' members shall be determined by the Chancellor, in consultation with the ASU System President. No board member shall serve more than two full terms. Initial appointments shall be made on a staggered basis.

5. The respective member institution's Chancellor shall nominate individuals for membership on the Board of Visitors. The ASU System President shall approve these recommendations.
6. The Board of Visitors shall elect from its members a Chair, Vice-Chair, and Secretary.
7. The Board of Visitors shall meet quarterly, and not later than two weeks prior to a regularly scheduled meeting of the ASU System Board of Trustees.
8. Regular minutes of the meetings of the Board of Visitors shall be kept by each member institution.
9. The Chair of the member institution's Board of Visitors shall be invited by the Chancellor to attend all meetings of the ASU System Board of Trustees, in order to support effective representation of each campus, and so that the Board of Visitors will have an enhanced understanding of the policies, procedures, and operation of the ASU System Board of Trustees.
10. A member of the Board of Visitors may be removed at any time by the Chancellor, upon approval by the President of the ASU System.
11. A member of the Board of Visitors will not be eligible for travel expense reimbursement, unless allowed by the law or ASU System policy.

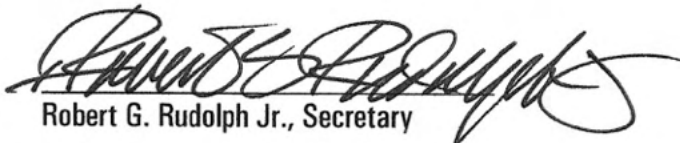
ISSUE: The Board of Trustees must approve changes to all ASU System Policies.

BACKGROUND:

- The System currently has a Student Accounts Receivable, Allowance for Doubtful Accounts, and Bad Debt Policy that was established in 2020.
- Among other provisions, the Policy states, "Financial holds will be placed on the release of academic transcripts/records." These holds are put in place if a student owes a debt to an ASU System campus.
- On July 1, 2024, a new rule from the United States Department of Education (Rule) takes effect, which alters the ability of higher education institutions to withhold academic transcripts. Among other changes, the Rule provides that an institution may no longer withhold entire transcripts, but may only withhold those portions of a transcript that were current during semesters in which federal financial aid was not repaid by the student. For other semesters, in which financial aid was paid, the institution must release those portions of the student's transcript. The Rule does not prevent institutions of higher education from withholding transcripts for non-federal institution charges.
- Because of the Rule's changes, and due to regulatory uncertainty, the System seeks to revise the Student Accounts Receivable, Allowance for Doubtful Accounts, and Bad Debt Policy to provide that any holds on transcripts will be discretionary. The revised policy will state the following: "Financial holds may be placed on the release of academic transcripts/records, as allowed by applicable laws and regulations."
- A copy of the revised Student Accounts Receivable, Allowance for Doubtful Accounts, and Bad Debt Policy is attached to this resolution.

ASU System Policy

Effective Date: June 6, 2024

Subject: Student Accounts Receivable, Allowance for Doubtful Accounts, and Bad Debt Expense

Purpose

The Student Accounts Receivable, Allowance for Doubtful Accounts, and Bad Debt Expense Policy is designed to protect the financial health of the System campuses and to meet the following objectives:

- Guidance for evaluating and accounting for the uncollectible portion of student accounts receivable, including writing-off uncollectible receivables and calculating an uncollectible receivable estimate,
- Consistency for all campuses in reporting the total student accounts receivable, allowance for doubtful accounts, and bad debt expenses, in order to ensure the effective administration of accounts receivable.

Definitions

Student Accounts Receivable: Amounts owed by a student as a result of enrolling at the University. This includes, but is not limited to, amounts for tuition, fees, fines, books, supplies, housing, and meal plans.

Allowance for Doubtful Accounts: Reasonable estimate, based on historical collections or other reasonable rationale, of the amount of accounts receivable that will become uncollectible. This amount is reflected as a contra-asset on the statement of net position.

Write-Off Process: Process to remove an amount owed to the University from the receivable balance after a collection process has been followed. The balance is no longer considered an asset and is not reflected in the financial statements.

Bad Debt Expense: The recognition in the financial records of the write-off process and the adjustment required to bring the allowance for a doubtful account to its required balance.

Policy Statement

Collections

A receivable becomes past due if payment is not received by the payment's due date. A concerted effort should be made to collect accounts. Each campus is responsible for establishing written collection procedures for accounts receivable.

Collection activities include any collection activities authorized by law.

Allowance for Doubtful Accounts

The process of calculating the estimate for uncollectible balances requires a rational estimate that follows Generally Accepted Accounting Principles (GAAP). Each campus will use the allowance method, in which estimates of the uncollectible accounts are applied as a percentage of outstanding accounts receivable as of June 30. The goal in recording the Allowance for Doubtful Accounts is to present, as accurately as possible, the net realizable value of accounts receivable on the University's financial statements.

Write-Off Process

While routinely executing collection procedures, some student accounts receivable will be determined to be uncollectible. Accounts should be written-off the University's financial accounting records when the collection process has been completed and management determines the receivable to be uncollectible. Each campus maintains the criteria and guidelines establishing the point at which receivables become uncollectible, and each campus is responsible for consistently performing the write-off of receivables. The abatement (write-off) of student accounts receivable shall be governed by Arkansas Code Ann. §19-2-306, as well as by the guidelines established by the Chief Fiscal Officer of the state.

This process ensures an accurate net receivables balance and is an important element of financial reporting. Amounts written-off are no longer reflected in the University's financial records; however, administrative and academic records will continue to reflect the student's enrollment and default status. Financial holds may be placed on the release of academic transcripts/records, as allowed by applicable laws and regulations.

Reporting

Based on audited financial statements and other financial records, the System will report annually to the Board of Trustees the following information:

- Total Accounts Receivable
- Total Student Accounts Receivable
- Allowance for Doubtful Accounts
- Net Student Accounts Receivable
- Total Amount Written-off
- Bad Debt Expense
- Student Accounts Aging Report

BACKGROUND:

- A-State wishes to move the Dietetics, Health Studies, and Public Health programs, which are all currently housed at the college-level, under the Department of Emergency Management and Occupational Health. The proposed reorganization will allow administrative duties to be streamlined for these existing programs that are currently not under a department. Additional benefits of the reorganization for the impacted programs include greater sharing of faculty expertise, expansion of community-outreach opportunities, and increased access to external funding sources.
- The renaming is tied to the reorganization and to other changes in programs being offered through the Department of Emergency Management and Occupational Health. Due to viability issues, the Paramedic and Emergency Medical Technician programs are in phase-out status, and it is no longer practical to include "Emergency Management" in the department name. The proposed name change from the Department of Emergency Management and Occupational Health to the Department of Health Sciences & Risk Management captures the disciplines that will be housed in the department after the proposed reorganization, and as a result of the phase-outs.

Be it resolved that Arkansas State University is approved to reorganize and rename the Department of Emergency Management and Occupational Health, within the College of Nursing and Health Professions, to become the Department of Health Sciences & Risk Management, as outlined above, effective Fall 2024.

ACTION ITEM: Arkansas State University Three Rivers (ASUTR) requests approval to offer an Associate of Applied Science degree, a Technical Certificate, and a Certificate of Proficiency in General Business.

ISSUE: The Board of Trustees must approve the offering of any new degree.

BACKGROUND:

- ASUTR will streamline existing business degree plans by developing a business core with specializations through directed electives in management, accounting, marketing, and data science. Alternatively, students can obtain a more generalized business degree by taking a variety of business electives.
- This 60-61 credit-hour program is structured to equip students with a survey-level understanding of business fundamentals, including communication, writing, collaboration, and professionalism. Students will delve into core general education and business courses across various disciplines, including management, technology, accounting, marketing, and economics. Through directed electives, students can select business courses, within a chosen focus area, to finalize a degree plan with a specialization. Students, who wish to pursue a more generalized business degree, can choose from any of the business electives.
- The A.A.S. degree in General Business will build from a nine-credit-hour Certificate of Proficiency in General Business, to a 30-credit-hour Technical Certificate in General Business, before the final A.A.S. degree. Our proposal will allow students to earn stacked credentials through substantial and focused academic control.
- The Certificate of Proficiency (CP) will include courses in introductory business, technology fundamentals, and basic management.
- The Technical Certificate (TC) will include all courses in the CP, along with intermediate-level business courses and general education requirements.
- The A.A.S. degree will include all courses in the CP and TC, with the addition of Business Communications, Financial Basics, Introduction to Business Analytics, Introduction to Marketing, Principles of Accounting, Legal Environment, 12 credit hours of general education requirements, the
